Introduction:

Rajganj High School Ex-Students Association (RAESA) is an association of all the ex-students whoever studied in the school regardless of duration of study. 'RAESA' to be used as the abbreviation of 'Rajganj High School Ex-Student Association'. Initially it was intent to abbreviate as 'RESA' but when it was discovered by one of our ex-students that very short form already being used by RAJUK Ex-Students Association and from then we move away from using RESA instead we decided to use the short form as RAESA where 'RA' comes as the first two letters from Rajganj, 'E' from Ex, 'S' from Students and 'A' from Association.

Motto:

Our pledges as a member of RAESA to be secular, non-racial, non-political, to be more human and not to make enemy but to make friends.

Mission & Vision:

Membership Qualification:

Category: Honorable and Honorary

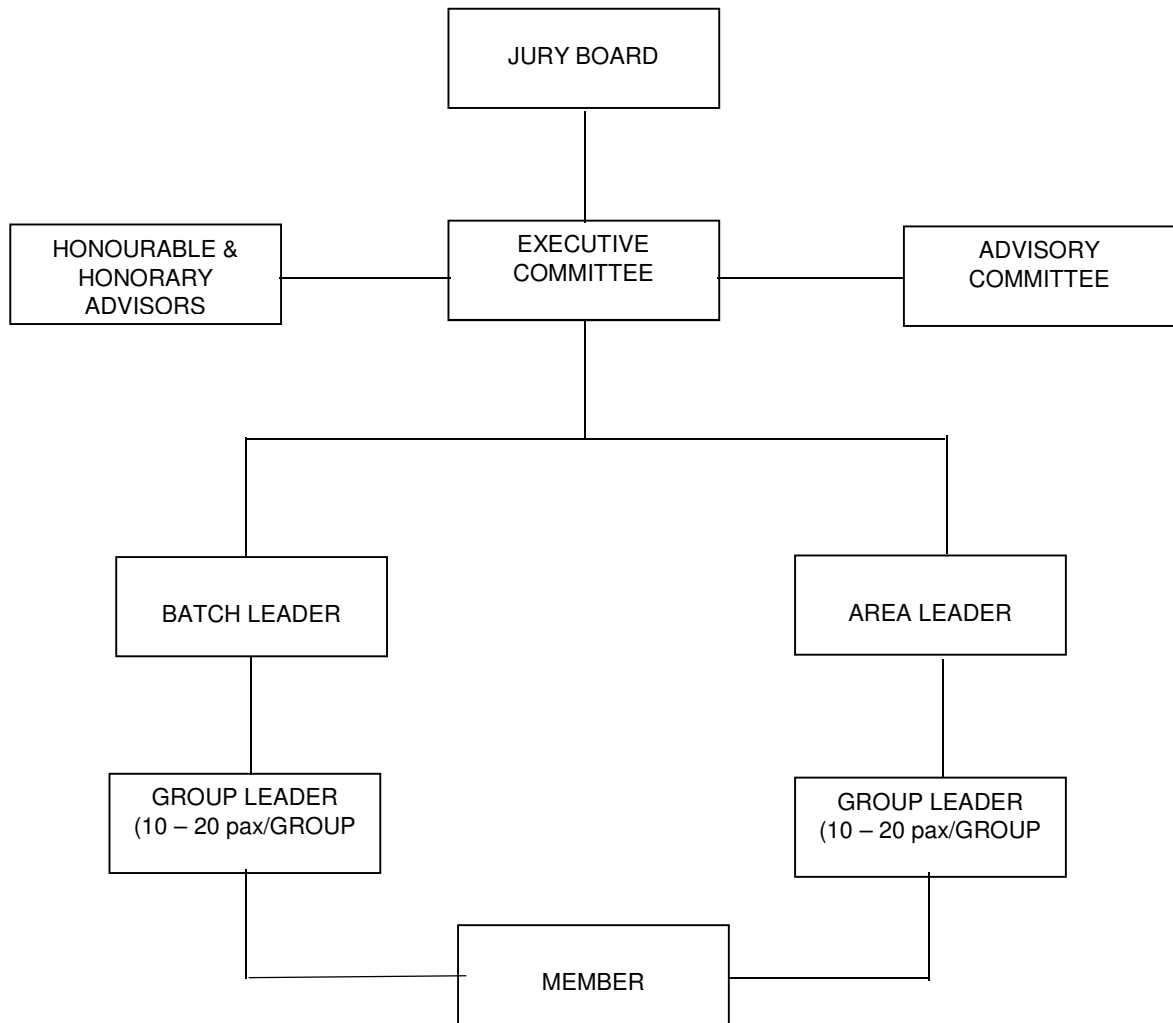


Figure 1.0: Organization Flow Chart

1.1 JURY BOARD

To be formed with maximum of 21 members including Chairman and Vice-chairman with minimum 3 senior lawyers. To become a member (including Chairman & Vice-chairman) of the Jury Board, he/she has to be the member of RAESA in the ex-student category.

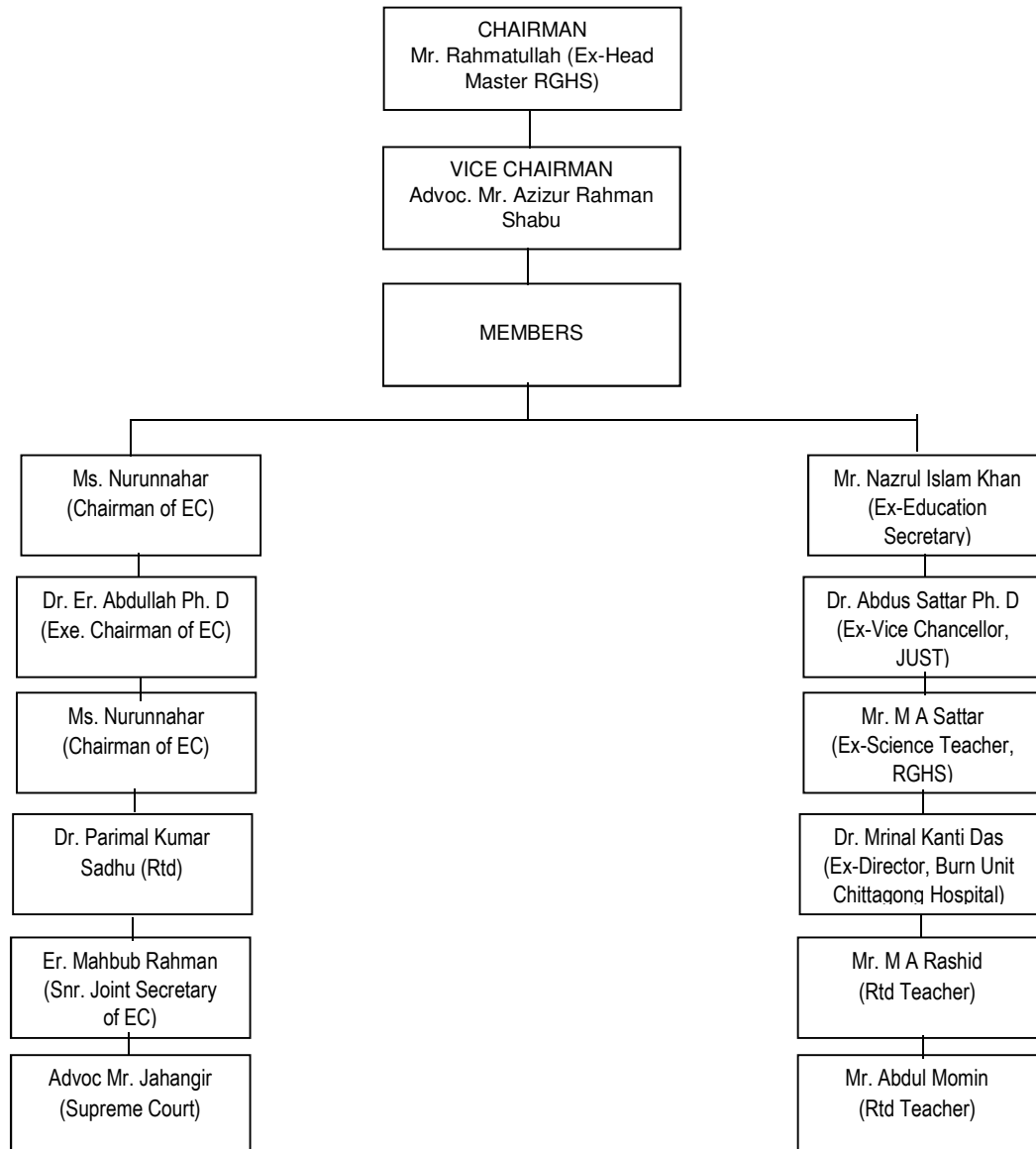


Figure 1.1: JB Organization Chart

1.2 ADVISORY COMMITTEE

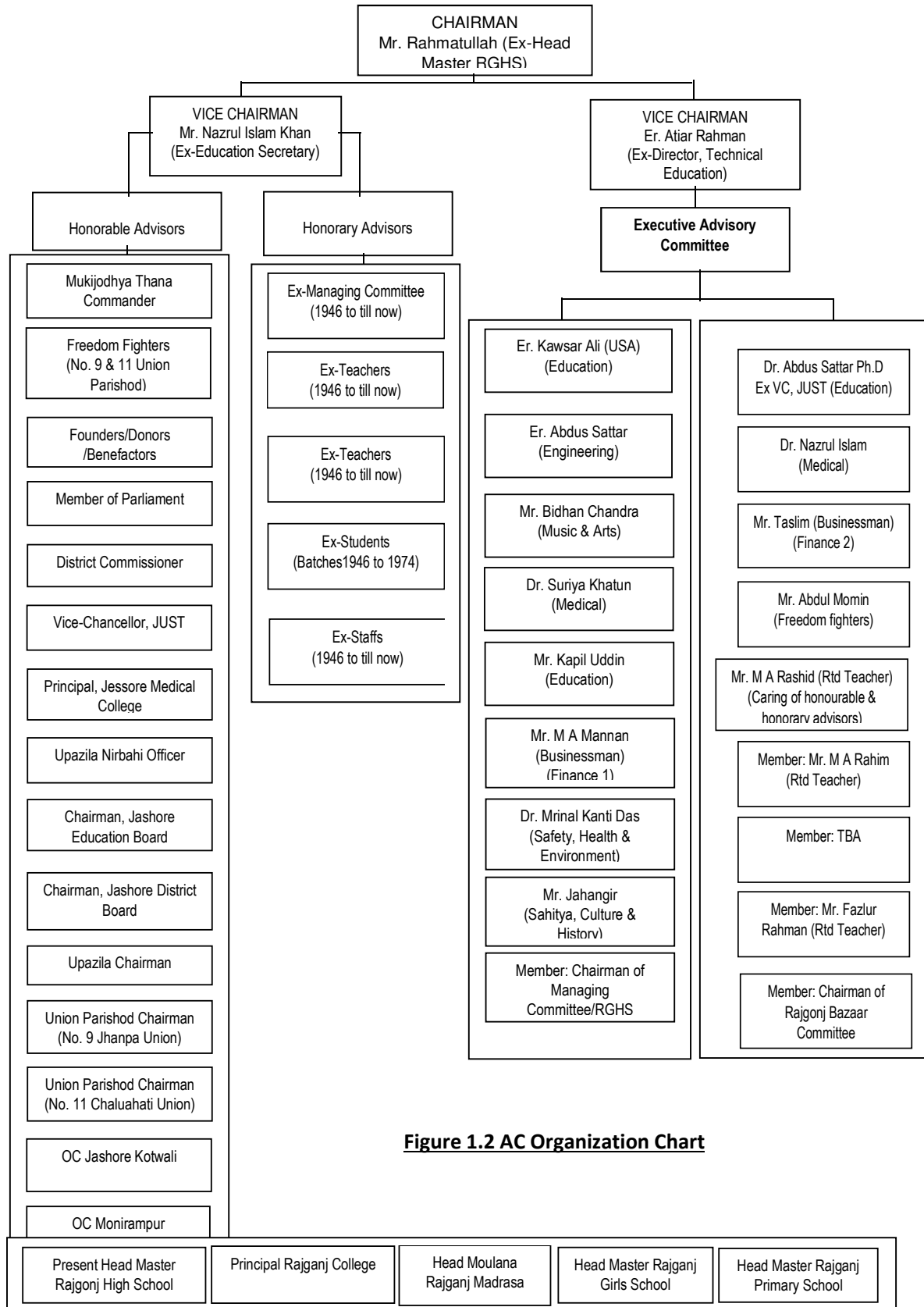


Figure 1.2 AC Organization Chart

It is subdivided into (I) Executive Advisory Committee and (II) Honorable & Honorary Advisors

(I) Executive advisory committee

To be formed with unlimited members other than the members who are designated with specific responsibilities. The designated advisors will be limited to 15 members inclusive of Chairman and Vice-chairman. The size of designated advisors and other members subject to executive committee's requirement. The basic qualification of being a member of the executive advisory committee is, he/she has to be the member of RAESA and yet to be subjected to executive committee's choice.

(II) Honorable and Honorary Advisors

- a) Honorable Advisors: Thana Mukhtijodhya commander, all the freedom fighters from no. 9 & 11 Union Parishad, high government officials and public representative elected by the people of the country. Other than freedom fighters and union parishad chairman (no. 9 & 11), the size of the honorable advisors is subject to executive committee's choice.
- b) Honorary Advisors: All the ex-managing committee members, ex-teachers, ex-students who turned to his/her 65 at the time of any reunion and the ex-staffs.

Both honorable and honorary advisors will be headed by a Chairman following up a Vice-chairman.

1.3 EXECUTIVE COMMITTEE

The committee will be headed by a Chairman followed an Executive chairman and a General Secretary, and the committee will hold the full responsibility of the integrity, growth and discipline of the organization. The size of the committee will be limited from Chairman to JSA as below;

(I) Joint Secretary (JS): (i) Office 1 2. Office 2 (ii) Caring of honorary and honorable advisors (iii) Safety & Environment (iv) Music & Arts (v) ICT (vi) Health (vii) Organizing, planning, education and R&D (ix) Freedom Fighters (x) Entertainment (xi) Finance (xii) Engineering (xiii) Medical (xiv) Sahitya, culture & history

(II) Joint Secretary (Organizing-JSO): (i) The leaders of a single or multiple village surrounding the school (ii) The leaders of the Cities, Towns & Upazilas (iii) The leaders of the individual batches

(III) Associate Joint Secretary (JSA): (i) an associate of JS & JSO

(IV) Group Leader (GPL): (i) A leader of 10-20/pax to be appointed by JSA

Members: All the ex-students except the designated members.

Note:

1. The detail duties and responsibilities for individual is under construction and will be introduced in due course.
2. In our first meeting one of the agenda to decide if we need to form the committee with Upper House (from chairman to JS) and the Lower House (JSA to GPL)

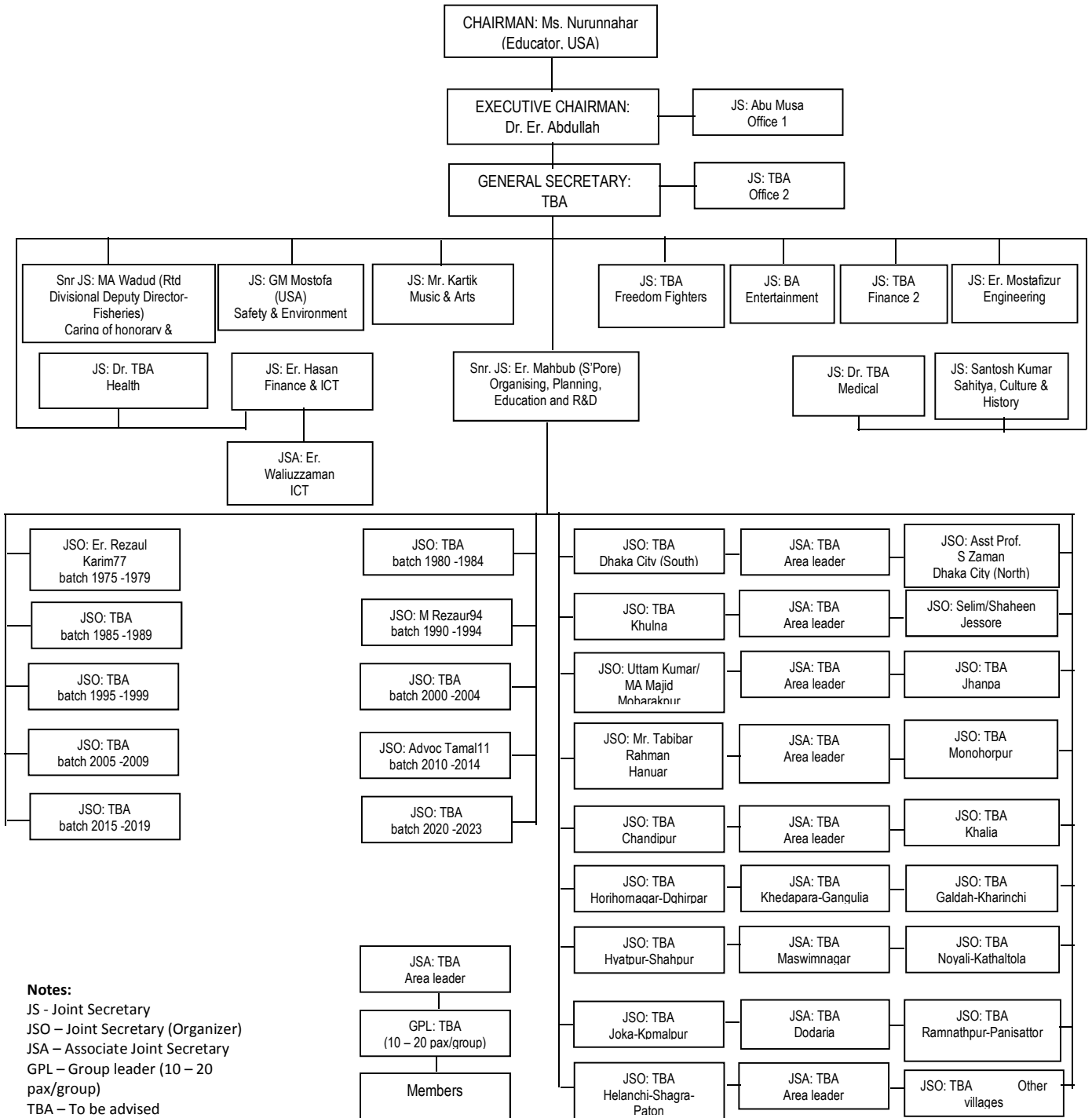


Figure 1.3: EC Organization Chart
